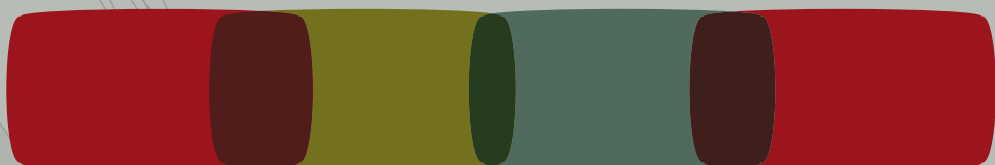

Terms and Conditions

THE TERMS

1. The Stanthorpe Art Festival 2010 is an acquisitive art award and exhibition, open to all forms of art media and organised by the Stanthorpe Art Gallery Society Inc. (SAGS). We are pleased to announce that we have obtained the services of Mr John McDonald as Judge for The Stanthorpe Art Festival 2010.
2. The competition is open to all artists.
3. Works chosen for the exhibition will be selected by the Judge from slides, jpegs or photographs (max A4) submitted with the entry. If the Judge is unavailable for pre-selection, an independent panel will be convened. Details of those comprising the panel will be notified to artists. Selected artists will be invited to submit works of art for exhibition and consideration by the Judge for **1st prize and/or acquisition**. The Judge may select more works than can be exhibited, in which case all works submitted will be viewed by the Judge and remain eligible for the prize and/or acquisition.
4. The Judge's decision will be final and no correspondence will be entered into.
5. It is intended that the majority of works submitted by artists will be shown in exhibition at the Stanthorpe Regional Art Gallery. Invitation to submit a work for final viewing by the Judge does not guarantee that the work will be exhibited; however the Judge will view all finalists.
6. We expect the Judge to nominate a winner of The Stanthorpe Art Festival 2010 and the winning artist will receive \$10,000. The Judge and the acquisition panel will select acquisitions up to the value of \$20,000 for the Stanthorpe Regional Art Gallery collection, (owned by the Southern Downs Regional Council). The winning work is eligible for acquisition.
7. The Judge reserves the right not to select a **winner** nor any work for acquisition, or not to allocate the full acquisition budget if works are not, in his/her opinion, of sufficient merit.
8. The Stanthorpe Art Gallery Society Inc. has the right to refuse to display any entry.

THE CONDITIONS

1. Entries must be forwarded to the Stanthorpe Regional Art Gallery by Friday 20 November 2009.
2. Entry forms accompanied by fees and images must be posted to: The Stanthorpe Art Festival 2010, PO Box 211, Stanthorpe, Qld. 4380 OR entry form accompanied by high quality images may be submitted via email with fees paid by accepted credit card. Late entries will not be accepted. Entry forms can be located on www.srag.org.au
3. All slides must be marked with the artist's name and short title of the work. **Please DO NOT attach sticky labels of any kind to slides.** All images submitted must be of works that have been executed since June 2008. **ONE** image should be marked indicating it as the preferred work for the exhibition. The Judge reserves the right to select an alternative work from the images submitted by the artist, in which case the artist will be consulted about that choice.
Digital images should be less than 2 megabytes, saved as jpegs and able to be opened on PC format.
Jpeg files should be saved with the following details as the file name:
Artist's surname_artist's first name_title.jpeg Example: Nolan_sidney_wimmera landscape.jpeg
Please note: CDs will not be returned.
4. Two dimensional work should not exceed 1.5 metres in any dimension or 2.25 sq metres in total. Measurements of three dimensional pieces should not exceed 1 cubic metre in volume with a maximum height of 1.5 metres and a base area no more than 1m x 1m to a maximum weight of 30 kilos.
5. **Entry fee is \$30.00 (incl GST) per artist.** One entry only per artist. One entry means a selection of up to three artworks, as set out on the entry form. **Entry fee is not refundable regardless of whether the work is selected for exhibition or not.** Any entry not accompanied by payment of entry fee will not be eligible for consideration for the award. Payment may be made by cheque, money order made payable to The Stanthorpe Art Festival or by credit card. Receipts will be included with letter of notification regarding success or otherwise in pre-selection process.
6. All works must be professionally prepared for hanging/installation with d-rings or screw eyes attached and must be clearly marked on the back with the artist's name and title of work. Works on paper should arrive framed with d-rings ready for hanging. Works on canvas should be suitable for handling. A stretched canvas is considered framed.
7. All works must be for sale. The Stanthorpe Regional Art Gallery will retain 33¹/₃% commission on any sales from the exhibition, including works acquired for the permanent collection.

8. Artists selected for exhibition will allow their works to be reproduced by print and electronic media in the advertising and promotion for the exhibition and for the exhibition catalogue. Stanthorpe Regional Art Gallery reserves the right to reproduce the winning entry and other acquisitions in subsequent publications by the Gallery in relation to The Stanthorpe Art Festival and permanent collection.
9. Freight of artwork is the responsibility of the artist. Artworks will not be accepted unless delivered and returned to artist free of all freight and other charges.

10. Collections of works: Exhibits may not be taken from the Gallery before 10am on Tuesday 20 April 2010. If a sale is conditional on the purchaser taking the work with them, this clause may be relaxed. Collections in person and by carrier may be made from 20 to 23 April 2010, between 10am and 4pm. Where return of works has been arranged and PREPAID, this Gallery will follow the artist's instructions as shown on entry form. Works not collected by 23 May 2010 will become the property of the Stanthorpe Art Gallery Society Inc. If an artist should fail or omit to remove a work from the Stanthorpe Regional Art Gallery as provided in these conditions, Stanthorpe Art Gallery Society Inc., after mailing a notice to the artist, at the last known address, of the intention to sell or otherwise dispose of such work, or in the event of no address being known to the Society, then one month after advertising the notice of intention in a newspaper, may sell such work and after deducting from the proceeds all incidental costs of the sale, shall hold any balance for the artist. Provided however, that in the event of such work being, in the opinion of the Society, unsaleable, then the Society may in lieu of the selling of the work, destroy or otherwise dispose of in such a manner as it may deem fit and thereafter the Society shall be under no liability whatever to the artist in respect of any work so destroyed or disposed of. All care will be taken.
- The Stanthorpe Art Gallery Society Inc. will not be responsible for any loss or damage, however caused. Insurance is the total responsibility of the artist.**
11. Official Opening: The Gala Opening of The Stanthorpe Art Festival 2010 will be hosted on Friday 26 February 2010. Complimenting the Exhibition will be gourmet food, wines and entertainment. Tickets must be purchased prior to 26 February. Cost: \$20 for exhibiting artists, artists who submitted an entry and members of Stanthorpe Art Gallery Society Inc., \$25 for others. Please indicate on the entry form the number of tickets you require for the Official Opening (if you wish to purchase tickets at this time).
